


Figure 1: New Economy Resources 2017 by Marcus P. Zillman, M.S., A.M.H.A.

# **BankTracker - Investigating Reporting Workshop**

The unprecedented bet that many banks made on mortgages, real estate development and other real estate-related lending during the middle part of this decade has produced a payoff no one imagined just a few years ago -- a huge increase in loan defaults, a soaring number of foreclosures and a plunge in bank profits. And now, an analysis of bank financial statements by the Investigative Reporting Workshop and msnbc.com, sheds new light on just how dangerous conditions have become in many banks across the nation. The analysis is based on reports every bank is required to file each quarter with the Federal Deposit Insurance Corp., the federal agency that protects deposits and is part of the bank regulatory system. The Investigative Reporting Workshop, a project of the School of Communication at American University, intends to address this fundamental issue for democracy in two important ways: a) By conducting significant investigative journalism projects on a national and international scale; and b) By researching and experimenting with new models for creating and delivering investigative projects.

The new Business Dynamics Statistics are a product of the Center for Economic Studies of the U.S. Census Bureau. The annual series describes establishment-level business dynamics along dimensions absent from similar databases including firm age and firm size. The new data series provides researchers with a tool to gain insight into the dynamics of a changing economy. Business Dynamics Statistics are created from the Longitudinal Business Database (LBD), a confidential database available to researchers throughout the network of Census Research Data Centers. The BDS was developed by the U.S. Census Bureau, and partially funded by the Kauffman Foundation. The BDS is unique in that its source data are longitudinal in nature and permit tracking establishments and firms over time. The public use files are created in an effort to make these data accessible to a broad range of data users. Other efforts currently under way include the creation of a fully synthetic microdata file based on the LBD. The BDS series provides annual statistics for 1976-2005 by firm age and firm size. Annual files are also provided at the state level, for Standard Industrial Classification sectors and for the economy as a whole.

The purpose of Data.gov is to increase public access to high value, machine readable datasets generated by the Executive Branch of the Federal Government. Although the initial launch of Data.gov provides a limited portion of the rich variety of Federal datasets presently available, they invite you to actively participate in shaping the future of Data.gov by suggesting additional datasets and site enhancements to provide seamless access and use of your Federal data. Data.gov includes a searchable data catalog that includes access to data in two ways: through the "raw" data catalog and using tools. As a priority Open Government Initiative for President Obama's administration, Data.gov increases the ability of the public to easily find, download, and use datasets that are generated and held by the Federal Government. Data.gov provides descriptions of the Federal datasets (metadata), information about how to access the datasets, and tools that leverage government datasets. The data catalogs will continue to grow as datasets are added. Federal, Executive Branch data are included in the first version of Data.gov. US Economic datasets are available from <a href="http://catalog.data.gov/dataset#sec-groups">http://catalog.data.gov/dataset#sec-groups</a>. These are "big data" federal.

Plan and build a universal, free, open, shared and continuously updated database of government jurisdictions/entities, their websites, and over time add elected official contact information. In the United States there are approximately 30,000 government jurisdictions. There is no official database of the websites tied to each jurisdiction be it a city, school district, or some relatively obscure special district. Business.Gov, an effort of the Small Business Administration, recently released an API with 8,000 or so city and county websites raising interest across many organizations in how to cover ALL government organizations. Once collecting and maintaining a directory of all government jurisdiction web addresses and a way to find your jurisdiction by entering a street address or by using a map is addressed, then deepening data collection to elected officials and all government owned or funded websites will be explored.

# Open 311 - Collaborative Model and Open Standard for Civic Issue Tracking $\underline{ \text{http://open 311.org/} }$

Currently, the most developed function of Open311 technologies is to report and track non-emergency issues in public spaces. Common issues include potholes, broken streetlights, garbage, vandalism, and other problems that compromise public spaces and infrastructure. Using a mobile device or a computer, someone can enter information (ideally with a photo) about a problem at a given location. This report is then routed to the relevant authority to address the problem. What's different from a traditional 311 report is that this information is available for anyone to see and it allows anyone to contribute more information. By enabling collaboration on these issues, the open model makes it easier to collect and organize more information about important problems. By making the information public, it provides transparency and accountability for those responsible for the problem. Transparency also ensures that everyone's voice is heard and in-turn encourages more participation.

Text Mining from Science and Technology Resources on the Internet by Kristen Cooper. Taken from the overview: "As defined by Bernard Reilly (2012), president of the Center for Research Libraries, text mining is "the automated processing of large amounts of digital data or textual content for the purpose of information retrieval, extraction, interpretation, and analysis." The first step is to find or build a corpus, or the collection of text that a researcher wishes to work with. Most often researchers will need to download this corpus to either their computers or an alternative storage platform. Once this has been done, different tools can be used to find patterns, biases, and other trends that are present in the text (Reilly 2012). Within higher education, text mining is most often found among the digital humanities and linguistics studies. However it is growing in popularity in the science and technology fields. It is possible to find many examples of how text mining is beginning to be utilized in the sciences. It allows users to search across a large set of documents to find connections that would be prohibitively expensive in terms of time to attempt to read individually. An example of this can be seen in the biomedical sciences where Frijters et al. (2010) used text mining to search in MedLine for drugs that could interfere with cell proliferation. Another example can be found with the works of the EXFOR library, which contains experimental nuclear reaction data. Hirdt and Brown (2016) used text mining to build a graph of the relationships between the reactions in the library. They were then able to use this information to identify reactions that are important to researchers but have been understudied. Text mining also has an ability to discover themes and relationships within a corpus through a technique called topic modeling. In a 2016 research study, the authors use topic modeling to determine the proportion of the analyzed text discussing a specific phenomenon, in this case forest fragmentation, and to determine the concepts that are most strongly associated with this phenomenon (Nunez-Mir et al. 2016). In an example from environmental science, Grubert and Siders (2016) use topic modeling to find empirical support for the theory that climate change has become an important topic in environmental lifecycle assessment over time, and revealed a secondary finding of this increase coming at the expense of attention to human health. Finally, the sheer amount of information available to researchers, educators, and scholars makes it increasingly difficult to stay current on a particular topic or field. Anne Okerson (2013) points out that text mining can be a useful and time saving factor in doing a systematic review. Text mining therefore presents librarians with the opportunity to develop skills in a new area that has the potential to be of great use to patrons." Peptides play significant role in cell signaling and function and can be used as an important tool for research and therapeutic treatments. Here we discuss both the structure and activities of peptides as well as strategies for their synthesis. Both peptides and proteins fall under a category called polypeptide chains. These chains contain two or more amino acids (forming amino acid polymers) that are coupled by a peptide bond. The bond is a special linkage between the nitrogen atom of one amino acid and the carboxyl carbon atom of another. Peptides differ from proteins by amount of amino acid residues the molecule contains. Polymer molecules with ten or fewer amino acid residues are called oligopeptides. Peptides often contain up to fifty amino acid residues, protein are molecules with more than fifty amino acid residues. Peptides are functioning in human body on many ways, such as regulating metabolism (insulin) and mediating pain signals (dynorphin). They also play a role in endocrine signaling and can act as a growth factor. Other organisms have produced peptides as a means for defense, such as fungal production of cyclosporin A used clinically as an immunosuppressant, and cone snail secretion of Ziconotide which is used to treat a pain. Modern medicinal and biochemical research is unthinkable without peptides application because of their selectivity, specificity and potency interaction with the target proteins. Peptides' large size and surface area allow for more specific docking to the target molecules. Researchers' interest in developing peptide ligands and probes for studying target receptors' structures and functions has increased dramatically lately. More recently, peptides have been considered as the desirable candidates for therapeutics. Not only can peptides be made very selective, decreasing the risk of side effects, but they rapidly metabolize by proteases and allow short time activity in the body. Peptides' activity can be lengthened by incorporating modifications, such as non-natural and D-amino acids, cyclization and modifications at the N or C-terminus. Therapeutic peptides also have some advantages compared to their protein counterparts. Biological therapeutics, which are generally proteins, have earned an increasing share of the pharmaceutical marketplace over the past few years. While biologics are often highly safe and effective, they must be produced in bioreactors, which use whole cells. Their purification and structural analysis is often complex and expensive. Further, biologics almost invariable must be injected. Peptides, on the other hand, can often be accessed chemically, and their purification and analysis is

much simpler. There is also an increasing number of examples of orally active peptides, which make them more desirable for drug development. Endogenous peptides have also been utilized for research and medical interventions. They can be monitored for diagnostic purposes, such as in the case of C-peptide, which is used to monitor insulin production and to help determine the cause of low blood sugar (hypoglycemia). ### **Abstract:**

Despite the rapidly growing body of work on public participation in citizen science, what and how participants learn by participating has received limited attention. This paper uses a digitization project underway at the Marie-Victorin Herbarium to explore the learning process of adult volunteers and show how scientific and digital literacies are constructed simultaneously and socially. In the process of digitizing the Herbarium's collection, volunteers draw on existing resources, including digital tools and sources, as well as create and share their own intermediary resources, thereby facilitating future work and enhancing informal learning. Individual goals — such as acquiring new skills or extending knowledge — are connected to the goals of the community — the production of a quality reference that will be available to everyone online. Volunteers are learning by doing, however, the lessons they learn extend beyond their local, situated context and may have a global and future impact.




Figure 1: Virtual Private Library<sup>TM</sup>
