### **BankTracker - Investigating Reporting Workshop**

The unprecedented bet that many banks made on mortgages, real estate development and other real estate-related lending during the middle part of this decade has produced a payoff no one imagined just a few years ago -- a huge increase in loan defaults, a soaring number of foreclosures and a plunge in bank profits. And now, an analysis of bank financial statements by the Investigative Reporting Workshop and msnbc.com, sheds new light on just how dangerous conditions have become in many banks across the nation. The analysis is based on reports every bank is required to file each quarter with the Federal Deposit Insurance Corp., the federal agency that protects deposits and is part of the bank regulatory system. The Investigative Reporting Workshop, a project of the School of Communication at American University, intends to address this fundamental issue for democracy in two important ways: a) By conducting significant investigative journalism projects on a national and international scale; and b) By researching and experimenting with new models for creating and delivering investigative projects.

Each Federal Reserve Bank gathers anecdotal information on current economic conditions in its District through reports from Bank and Branch directors and interviews with key business contacts, economists, market experts, and other sources. The Beige Book summarizes this information by District and sector. An overall summary of the twelve district reports is prepared by a designated Federal Reserve Bank on a rotating basis.

### **Business Dynamics Statistics, BDS**

The U.S. economy is comprised of millions of establishments with paid employees. The population of these businesses is constantly churning — some businesses grow, others decline, and yet others close. New businesses are constantly replenishing this pool. The Business Dynamics Statistics (BDS) tracks these changes over time, providing annual measures of establishment openings and closings, firm startups and shutdowns, and job creation and destruction. These measures are available for the entire economy, and by industrial sector, state, and MSA. They are also available by firm and establishment size and age. The BDS is created from the [Longitudinal Business Database](#) (LBD), a confidential database available to qualified researchers through secure [Federal Statistical Research Data Centers](#). The use of the LBD as its source data permits tracking establishments and firms over time. BDS data tables show key economic data: a) Employment – job creation and destruction; b) Job expansions and contractions; c) Number of establishments and firms; d) Establishment openings and closings; and e) Number of startups and firm shutdowns

There are several organizations that collect and give access to subsets of published CRS Reports. This collection attempts to bring all CRS Reports together in one place.

Congressional Research Service reports are the best way for anyone to quickly get up to speed on major political issues without having to worry about spin — from the same source Congress uses. The reports are not classified and do not contain individualized advice to any specific member of Congress. Until today, CRS reports were generally available only to the well-connected. The Digest of White House Announcements, Nominations Submitted to the Senate, Checklist of White House Press Releases, and Acts Approved by the President will continue to be made available electronically on a weekly basis.

Currently, the most developed function of Open311 technologies is to report and track non-emergency issues in public spaces. Common issues include potholes, broken streetlights, garbage, vandalism, and other problems that compromise public spaces and infrastructure. Using a mobile device or a computer, someone can enter information (ideally with a photo) about a problem at a given location. This report is then routed to the relevant authority to address the problem. What's different from a traditional 311 report is that this information is available for anyone to see and it allows anyone to contribute more information. By enabling collaboration on these issues, the open model makes it easier to collect and organize more information about important problems. By making the information public, it provides transparency and accountability for those responsible for the problem. Transparency also ensures that everyone's voice is heard and in-turn encourages more participation.

**A Decade of Writing On Wikipedia** by *James P Purdy*

#### **Abstract:**

This article reports what observable writing activities characterized three Wikipedia articles, *archive*, *design*, and *writing*, over a three-year period from 2012–2014. It then compares these results to writing in these same three articles 10 years earlier, from 2002–2004. Results show that articles were longer and more referenced in 2012–2014. The most frequent written contributions in 2012–2014 were adding and deleting content, followed by vandalizing and reverting vandalism. Ten years earlier, content addition was likewise the most frequent activity, though vandalism and its removal were not found. The least frequent written contributions in 2012–2014 were organizing and formatting content. Both activities occurred more often 10 years earlier. The number of contributors grew significantly in 2012–2014, though during both time periods approximately  $\frac{3}{4}$  of participants contributed only once. These results support that writing in Wikipedia continues to support notions of revision and collaboration valued in the discipline of writing studies. However, the revision and collaboration that occurred were limited. Thus, more robust approaches to these concepts are needed when using Wikipedia to

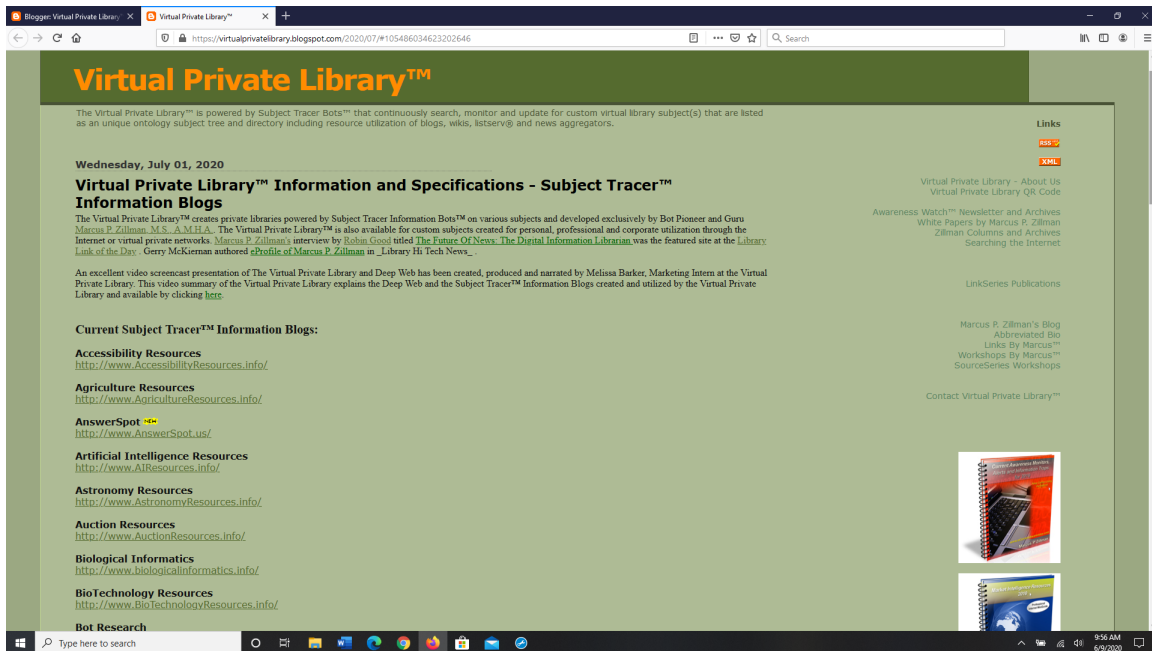


Figure 1: Virtual Private Library™
